

## HISENSE NBA CONFERENCE FINALS SWEEPSTAKES (THE “SWEEPSTAKES”) OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The Sweepstakes is sponsored by Hisense USA (the “**Sponsor**”). The Sponsor’s address is 7310 McGinnis Ferry Rd, Suwanee, GA 30024. The Sweepstakes is administered by Genesco Sports Enterprises, Inc. (the “**Administrator**”).

**1. ELIGIBILITY:** The Sweepstakes is open only to individuals who (i) are legal residents of the fifty (50) United States and the District of Columbia (the “**Eligibility Area**”); (ii) are eighteen (18) years of age or older (nineteen (19) years of age or older if a resident of Alabama or Nebraska) at the time of entry; (iii) agree to be bound by the terms of these Official Rules; and (iv) submit a valid Entry (as defined below) (each such individual, an “**Entrant**” or “**you**”). This Sweepstakes is not open to individuals who (i) are employees, officers, directors, agents and representatives of the Sponsor, the Administrator, the NBA Entities (defined as NBA Properties, Inc., the National Basketball Association (the “**NBA**”), and the NBA member teams, collectively, the “**NBA Entities**”), or any other entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes (such entities, collectively with the Sponsor and the Administrator, the “**Sweepstakes Parties**”); (ii) are immediate family (defined as parents, child, sibling, domestic partner, spouse and their respective spouses, regardless of where they reside) or household members (defined as those people who share the same residence at least three (3) months a year) of such individuals listed in clause (i) above; or (iii) do not meet these eligibility requirements.

**2. SWEEPSTAKES PERIOD:** The Sweepstakes begins at 12:00:01 a.m. Eastern Time (“ET”) on April 20, 2025, and ends at 11:59:59 p.m. ET on May 10, 2025 (“Sweepstakes Period”). The time clock of the computer administering the Sweepstakes is the time-keeping device for the Sweepstakes.

**3. HOW TO ENTER:** During the Sweepstakes Period, visit [www.WinWithHisense.com](http://www.WinWithHisense.com) (the “**Website**”). At the Website, register for the Sweepstakes by (i) providing your first name, last name, street address, city, state/province, zip/postal code, phone number and e-mail address; (ii) answering the questions to a short survey; and (iii) opting in to receive future marketing emails from the Sponsor\* (altogether, an “**Entry**”). Submit the Entry, as indicated, and you will receive one (1) entry into the Sweepstakes.

\*You may opt out of receiving marketing emails at any time by clicking the unsubscribe link in any such email that is sent to you. Please note that opting out of marketing emails will not affect your eligibility to enter the Sweepstakes.

You understand that Internet access and device data usage charges and any other charges imposed by your mobile plan (if you entered the Sweepstakes via a mobile device) and/or online service may apply when submitting an Entry. Contact your wireless carrier and/or check your mobile plan for data usage pricing plans and details.

**Entry Limit: one (1) Entry per Entrant throughout the Sweepstakes Period.**

Valid email address required. Multiple Entrants cannot share the same email address. Entrants may only use one (1) email address for the Sweepstakes; use of multiple email accounts is prohibited. Entries that exceed the stated limit or are incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries received or ranking status attained based on any tampering (cheating) or foul play will render that Entrant ineligible to receive any prize and may result in Entrant no longer being allowed to enter Sponsor's other promotions in the future, at Sponsor's sole discretion. In the event of a dispute as to any Entrant, the Authorized Account Holder of the email address used for Entry will be deemed to be the Entrant. The "**Authorized Account Holder**" is the natural person who is assigned an account by the Internet access provider, online service provider, or other organization responsible for assigning such accounts or the account associated with the submitted email address. A potential winner may be required to show proof of being the Authorized Account Holder.

**4. WINNER SELECTION:** On or about May 12, 2025, the Administrator will randomly select the potential winners from among all eligible Entrants who submit a valid Entry during the Sweepstakes Period. Odds of winning a prize depend upon the number of eligible Entries received during the Sweepstakes Period. Limit one (1) prize per person/household.

**5. WINNER NOTIFICATION AND CONFIRMATION:** The potential winners will be notified by the Administrator via phone and/or email at the phone number or email provided at the time of entry. The potential winners must accept the prize, as indicated within the notification message, within seventy-two (72) hours of notification or prize may be forfeited and awarded to an alternate winner. As part of the prize-claim process, the potential Grand Prize Winner will be required to complete, sign and return an IRS Form W-9 (including their social security number) and an Affidavit of Eligibility/Liability Release with (where lawful) a publicity release (altogether, the "Affidavit") within seventy-two (72) hours of receiving the email containing the Affidavit. Provided that a potential winner is in compliance with these Official Rules and after having successfully proven eligibility and provided the documentation required by Sponsor, such individual will be determined to be a "**Winner**". If, for any reason, more bona fide winners come forward seeking to claim a prize in excess of the available prizes, as set forth in these Official Rules, the winner(s) shall be determined by

All prize details not specified in these Official Rules will be determined at the Sponsor's sole discretion. If for any reason a prize is unavailable, Sponsor reserves the right to modify the Sweepstakes in its sole discretion and award a substitute prize, or portion of a prize, of comparable or greater value as set forth in these Official Rules. No substitution, transfer, assignment or cash equivalent of a prize, or any portion thereof, is permitted by a Winner. Any difference between the ARV and the actual value, if any, will not be awarded. The Sweepstakes Parties shall have no responsibility or obligation to a Winner who is unable or unavailable to, or who does not for any reason, accept or utilize a prize.

Sponsor also reserves the right to terminate, suspend, cancel or modify the Sweepstakes and award the remaining prize(s) for the Sweepstakes from among all eligible, non-suspect Entries received as of the date of termination using the procedure outlined above if for any reason this Sweepstakes is not capable of running as planned due to any reason, including acts of God, war, natural disasters, coronavirus (COVID-19) pandemic, other pandemics or epidemics or medical emergencies, government mandated lockdowns, weather, acts or threats of terrorism, strikes, lockouts, labor disputes, work stoppages, fire, acts of government, other force majeure events or other events outside of the reasonable control of the Sweepstakes Parties, infection by computer virus, bugs, tampering, fraud, unauthorized intervention, technical failures or other causes that may corrupt or impair the integrity, fairness or proper play of the Sweepstakes. By participating in the Sweepstakes, Entrants agree to these Official Rules and the terms and conditions of Sponsor's website and acknowledge all of the terms and conditions of the Privacy Policy.

**12. APPLICABLE LAW:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Georgia without giving effect to any choice of law or conflict of law rules (whether of the State of Georgia or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Georgia. Some jurisdictions do not allow for limitations of certain remedies or damages and so those provisions may not apply to you.

**13. DISPUTES/ARBITRATION:** The parties hereto each agree to finally settle all disputes only through arbitration; provided, however, the Released Parties shall be entitled to seek injunctive or equitable relief in the state and federal courts in Fulton County, Georgia and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Fulton County, Georgia. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Fulton County, Georgia. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

**14. GENERAL CONDITIONS:** The decisions of the Sponsor with respect to all aspects of this Sweepstakes are final and binding on all entrants without right of appeal. ANY PERSON FOUND TO BE IN VIOLATION OF THE LETTER AND SPIRIT OF THESE OFFICIAL RULES BY THE SPONSOR, FOR ANY REASON WHATSOEVER, MAY BE DISQUALIFIED AT ANY TIME, AT THE SOLE AND ABSOLUTE DISCRETION OF THE SWEEPSTAKES ORGANIZER.
